Certificated salaries were also reduced by (\$217,551) due to the elimination of Title I ARRA (\$370,845), IDEA ARRA (\$147,845), ARRA EETT (\$11,512) and CAPP (\$54,000). These amounts are offset by the reallocation of certificated staff to Title I \$264,538, SWP \$63,145 and SBCP \$43,704 along with (\$5,504) in miscellaneous changes. Classified salaries are reduced by (\$18,460) due to elimination of part time bus driver and maintenance retirements.</p> <p>2012-13 B2d: Certificated salaries are reduced by (\$3,026,432) due to the one time funding used from the Education Jobs Fund (2,522,591), the elimination of IDEA ARRA (\$77,355) and 7 resource teachers (\$426,486) funded 50% from Title II. Classified salaries are reduced by (\$583) due to miscellaneous changes.</p>
