It is the intent of the Oxnard Union High School District to minimize the use of chemical pesticides. When their use cannot be avoided, we will strive to utilize the least toxic appropriate method.

suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

## Chemical pest management practices

If non-chemical methods are ineffective, the school district will consider pesticides only after careful monitoring indicates that they are needed according to pre-established action levels and will use pesticides that pose the least possible hazard and are effective in a manner that minimizes risks to people, property and the environment.

This school district expects the following pesticides (pesticide products and active ingredients) to be applied during the year. (This list includes pesticides that will be applied by school district staff or licensed pest control businesses.):

Applications at all school sites will be based on published schedules with exception to emergency situations that are defined as an immediate threat to health and welfare of student and staff population. The approved pesticide list is as follows: 1.) Cyfluthrin 2.) Indoxacarb 3.) Pyrethrins/Piperonyl Butoxide 4.) Fipronil/1H Pyroazole3 Carbonitrile 5.) Diphacinone 6.) Capsaicin 7.) Dinotefuran 8.) Imidacloprid 9.) Borax 10.) Allethrin 11.) Brodifacoum

## Submittal of pesticide use reports

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt<sup>1</sup> from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at [www.cdpr.ca.gov/schoolipm](http://www.cdpr.ca.gov/schoolipm). (Education Code Section 16711)

(Education Code Section 17610.5)
